Procedure

Add STEPANOL® AM-V, NINOL® 40-CO, and EDTA to water and heat to 75-80°C with mixing. Add Di (Hydrogenated) Tallow Phthalic Acid, Dow Corning 200 Fluid, and Zinc Omadine. Mix for 30 minutes. Cool to 25°C with mixing and add Dye, Fragrance, and Preservative. Adjust pH to 5.0 - 6.2 with Sodium Hydroxide or Citric Acid as needed. Adjust to desired viscosity with Ammonium Chloride.
